address EEO issues.

In addition to chairing the Program Committee, the PACRAO Equal Educational Opportunity contact persons in 1987 and 1988, Jim Mansfield (University of Alaska) and Evelyne Glaser (Occidental College), have, along with AACRAO EEO committee member, Jim Dunning (UC Irvine), attended workshops held for EEO Contact Persons at the AACRAO annual meetings. At these workshops participants learn of AACRAO

efforts toward the advancement of equal educational opportunities both for students and professionals in the admissions and records field and how these efforts can be implemented at the regional level.

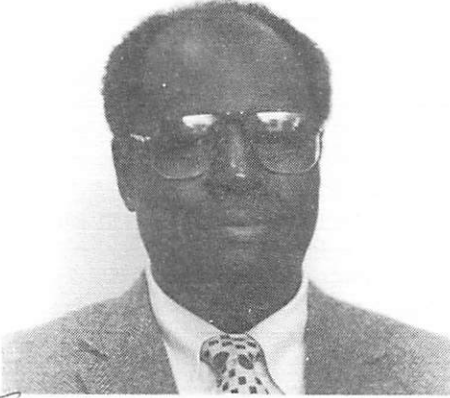

The Nominations and Elections Committee is pleased to offer the following nominees for PACRAO offices in 1988-89.

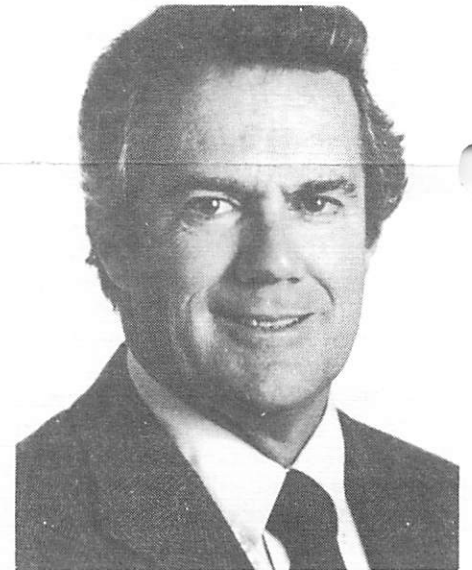


PRESIDENT ELECT

John Smith is Director of Admissions/High School-College Relations at Seattle Central College. A member of PACRAO since 1974, he served as PACRAO's Vice President for Two-Year institutions in 1986-87. John has served on the nomination rules change committee for PACRAO, served on PACRAO's program committee in 1986-87, has chaired several PACRAO program sessions, and has been a presenter at three PACRAO meetings. He introduced PACRAO's keynote speaker, Dr. Roz Woodhouse, at the Seattle meeting in 1987. John is Past President of the Washington Association of Community Colleges, Registrars and Admissions Officers (WACCRAO), and is currently Historian for WACCRAO. He is also President of Mt. Zion Baptist Church of Seattle Mens' Choir.

SET SAIL FOR PACRAO '88 IN LONG BEACH

Final preparations are taking place for PACRAO in Long Beach, November 6 through 9. - As you peruse the **program** in your registration packet, take special note of the comprehensive presentations planned for you. The Program Committee has met with great success in organizing a broad selection of professional presentations, seaside chats and information exchanges.

- Expect **weather** to be temperate: temperatures in Long Beach average 65-70 degrees F. in November, and the sun sets at approximately 6:00 p.m.

There is plenty of room for relaxing around the pool, a perfect way to meet and greet colleagues and friends. Just a short walk away is Shoreline Village, a waterfront shopping center, with a number of eateries and shops.
- Bring your **exercise** clothes for the Fun Run, the workout room at the Hyatt, bicycling along the ocean, or your favorite sports recreation.
- We will not be **taping** sessions in Long Beach, so you should plan to tape any sessions you wish to bring back to your campus.
