A MESSAGE FROM THE PRESIDENT

n November 1993, PACRAO membership approved a change to our bylaws, specifying that the President, in conjunction with the Executive Board and Program Chair, assume responsibility for "EEO" activities. I interpreted this as a clear desire to assure that PACRAO activities directed toward under-represented groups were thoughtful, integrated, and supported.

Toward this end, I considered suggestions from Cecilia Rodriguez, Herman Lee and Deanna Wong, and a serious discussion was pursued at the Executive Board meeting in January. We approved the following plan:

The President will appoint a PACRAOan as "Diversity Development Advocate". This person will attend Board meetings, and offer comment, assistance and plans for PACRAO's efforts to foster

diversity and professional development within our profession and with the association, vis-a-vis under-represented groups. The budget will include money to support travel of this person to Board Meetings.

The Advocate will create and manage a

special activity or activities for the annual conference, subsidized through the budget. The budget will also include money for a Professional Development/Travel Grant program, and the Advocate will work with the Vice-President for 4-Year Institutions on this.

The Advocate will be responsible for convening an ad-hoc committee to discuss and implement the following activities for 1994: creation of a mentoring program (or "buddy system") for newcomers of underrepresented groups at the annual conference; assisting the Vice President for 2-Year Institutions with membership development; considering special topics within planned summer workshops, or special summer workshops.

The Advocate is responsible specifically for professionals of color, but it would not be inappropriate to also oversee concerns of women professionals.

This is the plan for this year. Our

experience will tell us how to carry on in the following years. Should a permanent Board position be created? Should a standing committee be formed? Which activities deserve financial support? Is "Diversity Development Advocate" the best moniker we can come up with?

I want to hear from you, old-timer or newcomer. If you are interested in serving on the Diversity Development Advocate committee, call me at (503) 383-7243 right now.

Other news generated by Executive Board Activities is highlighted throughout this newsletter. Briefly, I will say that the Spokane conference already has the markings of a winner (especially its reasonable cost); that Summer Seminars will be HOT; that you should return your dues statement with payment on time because that's the only way you'll get the new and improved directory with e-mail and fax numbers; and that there's lots more to come from this vital association.

PACRAO MEMBERSHIP SPEAKS OUT

hanks to 197 of you, our January membership survey effort was successful. We have a gold mine of information with which to plan our priorities and activities.

The good news is that 43% reported that their involvement with PACRAO has stayed the same, and 32% reported that their activity has increased. We interpret this as a strong vote of confidence in the services and benefits of PACRAO. Many commented on the difficulties with their institutional budgets, though, reminding us to keep lean and mean.

Respondents indicated a strong preference to continue our emphasis on the annual conference, though this is balanced by responses which indicate a growing desire to have more "drive-in", lower-cost workshops. The appeal of the Summer Seminars' low fees and target toward front-line staff apparently is not lost on PACRAO members.

Ratings and comments indicate interest in a meatier newsletter. Our membership directory is rated satisfactory, but there were many requests for e-mail and fax numbers.

Members indicated satisfaction with PACRAO's emphasis on activities directed toward women and professionals of color.

The runaway item concerned leadership opportunities in PACRAO. Most respondents wanted more opportunities.

A minority of respondents indicated a desire for change in PACRAO's emphasis and conferences. However, most of the comments were favorable and included valuable suggestions: more technical sessions at the conference, more sessions about personal development, a Saturday-Tuesday conference schedule, better inclusion of admissions, community college and Canadian interests, and an increased recognition of newcomers. There was no substantial interest in a bi-annual (every two years) conference.

We also discovered that the respondents not only take time to answer surveys, but that about half of them are involved in state AACRAO-type associations and AACRAO. Busy folks!

Based on responses, the Board has made a stronger commitment to the newsletter, will add e-mail and fax numbers to the directory, is making efforts to enlarge participation and leadership roles, and is slimming its budget to keep services affordable. And there will be more...

About half of the respondents indicated an interest in involvement, and some even gave us their names! These names have been referred to the Program and LAC committees for Spokane

as well as listed for future possibilities. Another way to become more involved is to apply for a professional development grant (see Newsletter insert for proposal information). Our challenge is to be fully responsive.

Thanks to Jesse Welch and his staff at PSU for printing and mailing the survey; and to you, for responding.

STATUS OF EARTHQUAKE RECOVERY EFFORTS AT CALIFORNIA STATE UNIVERSITY-NORTHRIDGE

alifornia State University-Northridge, with its approximately 25,000 students, is the fourth largest in the 20-campus California State University system. The campus consists of over 100 buildings, spread out over 353 acres in the heart of the San Fernando Valley, a suburb of the city of Los Angeles, containing 1.2 million of the city's 3 million population.

The 6.6 earthquake which struck Northridge in the early morning hours of January 17th, disrupted life in the area and at the University in profound ways. No major public university in the nation has ever experienced the extensive damage and disruption wreaked upon CSUN in just 40 seconds. All buildings on campus have been affected to some degree.

Despite the enormity of problems, the University was committed to rebuilding a program for the spring semester, which began February 14th- a scant two weeks later than normal. To achieve this goal:

The University sented 300 single steps temperature.

■ The University rented 300 single-story temporary structures at a cost in excess of \$5.5 million for a


period of six months. These temporary buildings have been and will be placed around the campus for use as interim classrooms, faculty offices, and meeting spaces.

■ Class schedules have been redesigned to provide continuous instruction 7am to 10pm weekdays and extended hours on Saturdays in an effort to accom-

modate student needs with a limited number of useable classrooms.

■ The University has accelerated its plan for creating a one-stop student access center, which will combine student advisement, career counseling and financial aid in one location.

The University has incurred substantial cost in preparing the campus for reopening. To date, the University has:



nation's history. Based on expenditures to date and on data that we have been able to accumulate this far, rough estimates to rebuild the University have reached \$300 million, making it surely the costliest disaster to a major public higher education institution in the country.

Total recovery will depend on the joint commitment of local, state, and federal resources. California State University-Northridge is grateful for and urges support of Congressional efforts to assist in the recovery process.

IN MEMORY...

oward Shontz was very active in PACRAO and AACRAO during his 47-year career with the University of California. He began at Berkeley, first as a student and later as an employee. He moved on to Davis, then to Santa Cruz and completed his career back at Berkeley in the Office of the President,

Howard was PACRAO President in 1963 and attended his last PACRAO meeting in Sacramento in 1989, the year before his death.

Howard was an effective administrator, sensitive counselor, and valued friend to all who knew, worked, and laughed with him. He was able to balance his work and home life by intertwining office, associational, and personal responsibilities and tasks. His widow, Lurie, is as familiar with PACRAO as many of our colleagues.

Lurie gave me, as PACRAO President 1993, Howard's AACRAO pin. She thought, and I readily agreed, that it would be appropriate for Howard's pin to continue active exposure. I, at the business meeting of the 1993 Annual Conference in Sparks, gave the pin to incoming President, Christine Kerlin, who will, at the conclusion of the Spokane Annual Conference, November 1994, pass it along to Melanie Bell, President-Elect. In this way, Howard's contributions to both PACRAO and AACRAO, as symbolized by his pin, will remain active and productive.

AACRAO recently designed and has made available for distribution a new pin, however, the old style retains the association's distinctive color and logo. It seems to be a fitting tribute to the memory of a colleague who contributed so much. Submitted by Roger Anderson, Past President 1994

- Expended \$1,500,00 for emergency telephone service to the temporary buildings; \$3,000,000 in short-term instructional equipment rentals; and \$1,000,000 to equip student labs with 400 computer stations. Until access to buildings is permitted, it is not known how many of the University's 5,200 pre-earthquake computer stations survived.
- Expended \$22,000 per day in asbestos cleanup campus-wide and \$25,000 per day on hazardous chemical clean-up, primarily in the 4 science buildings.
- Expended \$3-\$5,000,000 in professional structural engineering evaluations of all campus structures; \$50,000 for testing campus electrical systems and underground trunk lines; and \$500,000 in emergency supplies (gloves, flashlights, hard-hats, tents, and plastic sheet for roofs).
- Expended \$840,000 in demolition and heavy debris clean-up for buildings.

The impact on records, academic and non-academic, has been incredible:

- All of the University's communication systems have been disrupted; phone service is skeletal; data systems such as e-mail, Internet, and other local networks are not operational; mail service has been re-established, but the backlog is immense.
- Student loans and financial aid checks exceeding \$7 million are stored in a safe in a building which is currently inaccessible.
- earthquake struck, was disrupted. At great risk to life and limb, CSUN employees climbed through a fourth floor window in the South Library which houses the University's computer operations and mainframe to rescue computer back-up tapes. These tapes were subsequently transported to our sister campus in Fresno, thus enabling the registration process to continue.
- Production of academic transcripts needed for job and graduate school applications was also interrupted. No official transcripts had been issued from January 14th to February 14th.
- All student files located in Admissions and Records will need to be reassembled once access to the severely damaged Administration building is permitted.
- Business and personnel records located in the administration building are inaccessible. Until the building can be entered, all business and personnel operations have been postponed. The evaluation process for employees has been postponed; recruitment which was underway for faculty and staff for the spring semester has been delayed. In addition, the employment verification process has been interrupted.

The University faces an awesome task in its effort—in the short term, to mount a viable instructional program which will enable students to continue process toward their degrees, and in the long term, to rebuild the campus. We have been greatly assisted in a variety of ways.

The CSU Chancellor's Office made a commitment to revitalize the campus as quickly and effectively as possible by relaxing deadlines, policies and procedures in order to expedite reopening of the campus. It also assembled a FEMA team to assist the University.

Seventeen CSU campuses sent police officers to assist with securing the interior and

perimeters of the campus. Other campuses provided custodians, ground workers, laborers, electricians, haz mat and filming crews, and administrative staff. Campuses have also provid-

ed their facilities for a variety of purposes ranging from touchtone registration to temporary housing for laboratory animals. Two campuses are sending small modular buildings.

In addition, other local institutions within the University of California and the California Community Colleges systems have contributed to the Cal State Northridge recovery effort.

Help has been received from both the California Conservation Corps, which continues to provide 24-hour perimeter security for the campus, and the Orange County Search and Rescue team, whose members arrived very early on the scene with a horse patrol, medical team, generators, tents, and who helped clear away heavy debris.

We are truly grateful for the assistance we have been provided, without which the institution could not have contemplated reopening even a limited program in such a short period of time. Much remains to be done in order to achieve total recovery. The total financial impact to rebuild California State University-Northridge will not be known until afterschocks have abated and buildings have stabilized to the point where re-entry and assessment can take place.

The Northridge Quake has already been described as the costliest natural disaster in the

PACRAO Professional Development Grant

STATEMENT OF PURPOSE

The PACRAO Executive Board is committed to returning PACRAO assets to its members.

The PACRAO Executive Board believes development activities can benefit both the individual and strengthen the expertise of the PACRAO region.

Therefore, the Executive Board will create a professional development fund each budget year (in addition to the PACRAO Conference Travel Grant) and disburse it to members who, through the application and proposal process, are judged to merit such assistance as PACRAO funds can provide.

PROCESS

- 1. Budget for the professional development fund will be decided at the February Executive Board meeting.
- 2. Responsibility for professional development grant administration lies with the Vice President for Four Year Institutions.
- Announcements of the professional development grant opportunity and application and proposal process will appear in the PACRAO newsletter, on the PACRAO listsery, and by separate mailing, if necessary.
- 4. Applications will be reviewed by the two Vice Presidents, the President, and President-Elect, and coordinated by Vice President for Four-Year Institutions. It is implicit in their duty that this be done in a timely manner. Application deadline is June 1.
- 5. Special consideration will be given to proposals which address:
 - A. Original research, and/or
 - B. Problem resolution, and/or
 - C. Topics of diversity and/or
 - D. Activities that may benefit and serve the PACRAO region.

However, other circumstances may be considered.

- 6. The Vice President, Four Year Institutions, will notify the applicant and supervisor in writing of the award.
- 7. Award amounts may vary, depending upon the amount in the budget, the number of applicants, and the merits of each proposal.

GUIDELINES

A written proposal should be concise and clear, stating what is to be accomplished, who will complete the work, the cost, and the length of time needed to complete the project. The proposal should be factual; and avoid generalizations. Be prepared to redirect goals and rewrite the proposal if required. Proposals for professional development can include funding to do original research on a topic; implement solutions already identified; attend special interest workshops or conferences; etc.

The following are the items which the proposal should address:

- Introduction and Objectives: Summarize logically and concisely why the applicant wishes
 to do the activity. Establish benefits which will result from the activity. Explain the
 objectives.
- Summary: Make a brief statement of the major features or structure of the proposal.
 Provide an objective judgement of the importance of the activity. Indicate possible sources of cooperation with other groups or identify any duplication of effort.
- 3. Need for the Activity: Establish the need for the activity indicating why and how it has not been satisfied.

- 4. Methods: Indicate the activities to be used to achieve the desired results. Cite "milestones" (dates) for completion of each part of the activity, if appropriate.
- 5. Dissemination: Indicate to whom the findings will be sent and in what medium and format, if appropriate.
- 6. Budget: Break down costs by individual category. Indicate if separate publication funds are needed. Indicate travel costs, number of individuals involved, support staff costs, etc. If the project will extend beyond one fiscal year, budget figures should be projected for each fiscal year until completion.
- 7. Time Schedule: A time line or table should be included to indicate when meetings/ events are to happen and when the activity is targeted for conclusion.
- 8. Evaluation: Describe a way to measure the degree to which the project has met objectives and a specific activity that can benefit the PACRAO organization.
